| C12 – Trainee internal audit allowance Trainee Internal Auditors will be required to obtain the UK Treasury's Government Internal Audit Standard (GIAS) or the Institute of Internal Auditors Practitioner Qualification (PIIA). They may also be required to obtain the Institute of Internal Auditors (MIIA). Upon achieving the required qualification, civil servants will receive the lump sum payments as detailed in <u>Annex C3</u> . | |
| C13 Legal allowance A Student at Law who has been admitted by the Public Services Commission into articles within HM Attorney General's Chambers in order to become qualified as an advocate shall be eligible to receive the lump sum payments listed in <u>Annex C3</u> : <ul style="list-style-type: none">• on successful completion of the final examinations for admission as an advocate and• on appointment to the staff of the Attorney's Chambers for a period of not less than 6 months | |

Proposed Amendment:

C12 – Trainee internal audit allowance

Trainee Internal Auditors will be required to obtain the ~~UK Treasury's Government Internal Audit Standard (GIAS) or the Institute of Internal Auditors Practitioner Qualification (PIIA)~~ Institute of Internal Auditors Certificate in Internal Audit Qualification (CIA). They may also be required to obtain the Institute of Internal Auditors ~~(MIA) Qualification in Internal Audit Leadership (QIAL)~~. Upon achieving the required qualification, civil servants will receive the lump sum payments as detailed in Annex C3.

C13 Legal allowance

A Student at Law who has been admitted by the Public Services Commission into articles within HM Attorney General's Chambers in order to become qualified as an advocate shall be eligible to receive the lump sum payments listed in Annex C3:

- on successful completion of the final examinations for admission as an advocate and
- on appointment to the staff of the Attorney's Chambers for a period of not less than 6 months
